Resmini Law Gets Results for You

The Law Offices of Ronald J. Resmini reached a settlement for **\$5,000,000** in a case involving catastrophic personal injuries resulting from a motor vehicle crash.

Other Settlements:

The Law Offices of Ronald J. Resmini secured **\$400,000** for a pedestrian who suffered a mild traumatic brain injury after being hit by a car while walking in a parking lot. The settlement consisted of the full policy available from both the at-fault party and the injured plaintiff's underinsured motorist coverage.

The Law Offices of Ronald J. Resmini secured **\$180,000** for a shopper who fractured her hip when a large item fell from a supermarket display, hit her shopping cart, and caused her to fall to the ground. Her injury required surgery and months of rehabilitation.
